Title: Procurement of Data Loggers

1. The People's Republic of Bangladesh has applied for a loan from the Asian Development Bank (ADB) toward the cost of Dhaka Environmentally Sustainable Water Supply Project, and it intends to apply part of the proceeds of this loan to payments under the contract for "Procurement of Data Loggers" under Dhaka Environmentally Sustainable Water Supply Project of DWASA, Contract No. ICB-05.5B. This contract will be jointly financed by ADB and the Government of Bangladesh (GoB). The eligibility rules and procedures of the ADB will govern the bidding process.


2. The Dhaka Environmentally Sustainable Water Supply Project now invites sealed Bids from eligible Bidders for "Procurement of Data Loggers" for Dhaka WASA under Dhaka Environmentally Sustainable Water Supply Project (DESWSP). The delivery/ completion period is **120 days**. The following are the main items to be delivered under the package:

3. Qualification Criteria for Bidders:

- **Average Annual Turnover:** The minimum annual average turnover shall be **BDT 20.00 million (US\$ 0.25 million) in last three years.**
- **Contractual Experience:** The Bidder must have successfully completed as a main supplier within the last 5 (five) years, 2 contracts each of similar nature (import / export of goods), value **above BDT 7.40 Million (above US\$ 0.095 Million)** and complexity.
- **Technical Experience:** Goods offered have been in production for at least 2 (two) years and a minimum of 5 times the scheduled number of units of similar capacity have been sold every year.
- **Financial Position:** At a minimum, the bidder must have a positive net worth. The bidder shall submit at least last 3 (three) year's audited financial statements for this purpose.


7. The Purchaser will arrange a **pre-bid meeting on 16 July, 2017 at 10.30 AM**. Bidders and their local agents are strongly encouraged to attend the pre-bid meeting. If requested, the Purchaser will issue a letter of invitation to support a visa application on behalf of the bidder up to one week before the pre-bid meeting date. To assist in the planning for the meeting, it is requested that within seven days after purchasing the document the bidders advise the undersigned on the number of people that will be attending.

8. Bids must be delivered to the address below at or before **2:00 pm (Bangladesh time) of 7th August, 2017**. All Bids must be accompanied by a **Bid Security** as stated in the Bidding Document (Bid Data Sheet). Late bids shall be rejected. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below at **2.15pm (Bangladesh time)** the same day.

9. For purposes of determining the equivalent of the required amount of the Bid Security in other freely convertible currency, the selling exchange rates published by the Sonali Bank Ltd, Dhaka on the date 28 days prior to the deadline for bid submission shall be applied.

10. The **Dhaka Environmentally sustainable Water Supply Project (DESWSP)** will not be responsible for any costs or expenses incurred by Bidders in connection with the preparation or delivery of Bids.

11. In the comparison of Bids, ADB's Domestic Preference Scheme will be applied in accordance with the provisions stipulated in the Instructions to Bidders.
